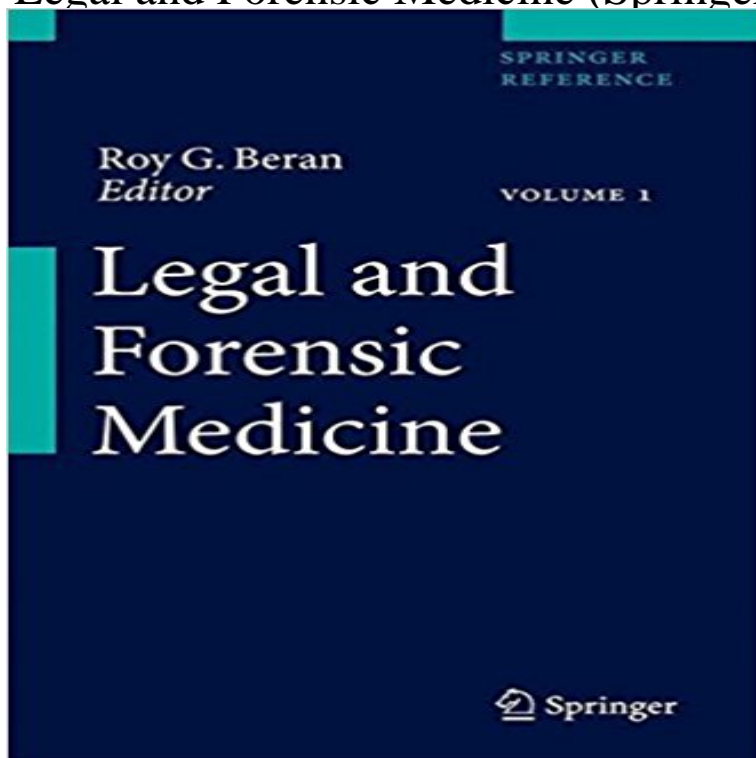


Legal and Forensic Medicine (Springer Reference)
